MARAZOFF advised that in approximately 1991, she lived with MARK THOMAS and had two children by him, MORIAH THOMAS, Date of Birth (DOB) October 14, 1991 and NICHOLAS MARAZOFF, born December, 1994. MARAZOFF stated that she had seen a recent newspaper article in a Reading, PA, newspaper which indicated that MARK THOMAS might be testifying in the Oklahoma City bombing case in Denver, Colorado. She indicated that the purpose of her telephone call was to advise the FBI of her knowledge of the bombing.

MARAZOFF recalls that sometime prior to February, 1995,
MARK THOMAS was visiting her at her residence at

, PA. The purpose of this visit was for him to

visit with his two children, MORIAH and NICHOLAS. During the
course of this visit, THOMAS began talking about the federal
government and their involvement in "Waco" and "Ruby Ridge".
THOMAS became very irritated as he continued to talk about these
two incidents and during the course of the conversation, made the
following statements:

"We are going to get them. We are going to hit one of their buildings during the middle of the day. It's going to be a federal building. We will get sympathy if we bomb the building." THOMAS made additional statements something to the effect, "That the people who will lose their loved ones, will realize how bad it feels."

MARAZOFF advised THOMAS at that time that she did not feel that this was the appropriate action to take and that innocent people should not be harmed because of some improper actions in the past by the federal government.


